Bridge to Brilliance delivers tertiary education to qualifying students residing in the Bahamas. It's an opportunity to enroll in an online degree program at DeVry University with significant grant tuition rate savings as outlined below.

As a qualifying student, your first academic session at DeVry is complimentary\*, so you can embark on your education journey in a program that can fit with your budget, your plans and your life. From your second session forward, you can enjoy continuing award benefits as a student at DeVry University or its Keller Graduate School of Management.

## How do I apply?

The Bridge to Brilliance program is available for eligible new and readmit\* undergraduate and graduate students residing in the Bahamas.

Eligible Degree Programs	Any degree or certificate program from DeVry University that can be delivered online is available for qualifying Bahamian residents to enroll in, including undergraduate or graduate certificate, associate, bachelor's, or master's degree programs. TechPath or non-TechPath programs are eligible. Undergraduate Tuition Savings	<ul style="list-style-type: none"> <li>• <b>100% complimentary first session</b> of enrollment, including tuition and fees<sup>+</sup></li> <li>• <b>61% Undergraduate Grant tuition savings</b>** from the second session forward</li> <li>• <b>100% savings benefit</b> for Course Resource Fees, eBooks and Student Services Charges</li> </ul> <p><i>**Students receiving the Bahamas Scholarship prior to May 2020, will be transitioned into the Bahamas Grant and will be notified. In the event of future changes to DeVry's Undergraduate prevailing tuition rate, the tuition savings amount for eligible students will continue to be similar and not exceed \$225 per credit hour.</i></p>
Graduate Tuition Savings	<ul style="list-style-type: none"> <li>• <b>100% complimentary first session</b> of enrollment, including tuition and fees<sup>+</sup></li> <li>• <b>48% Graduate Grant tuition savings</b> from the second session forward—the prevailing graduate tuition rate currently equates to \$403.52 per credit hour***</li> <li>• <b>100% savings benefit</b> for Course Resource Fees and eBooks</li> </ul> <p><i>***In the event of future changes to Keller's Graduate prevailing tuition rate, the tuition savings amount for eligible students will continue to be similar and not exceed \$425 per credit hour.</i></p>
Initial Eligibility	<ul style="list-style-type: none"> <li>• Student must have an approved recommendation by BIBT provided to DeVry.</li> <li>• Complete pre-enrollment interview with local BIBT Enrollment Coordinator.</li> <li>• Present Bahamian Proof of Residency.</li> <li>• Enroll as an online student in an eligible program and meet admissions requirements.</li> </ul>
Restrictions	<ul style="list-style-type: none"> <li>• Cannot be used in combination with DeVry University Grants or Scholarships, or group-specific tuition rates, including military, Family Forward and any other DeVry savings programs.</li> <li>• Students who have not received an approved recommendation by BIBT are not eligible.</li> <li>• Students who do not present required Bahamian Proof of Residency documentation are not eligible.</li> <li>• The grant is tuition and fees restricted and will NOT result in a monetary refund to student.</li> <li>• This is a program administered 100% online for students residing in the Bahamas. This is not an F1 Visa program by which students would be eligible to take classes onsite in the United States.</li> </ul>
Required Documentation	<ul style="list-style-type: none"> <li>• Bahamas Grant Acknowledgement Form signed by student, BIBT Enrollment Coordinator</li> <li>• Direct Bill Payment Plan Agreement Form</li> <li>• FERPA Release Form</li> <li>• Bahamas Grant Program Terms &amp; Conditions Form (upon grant approval)</li> </ul>
Continued Eligibility	<ul style="list-style-type: none"> <li>• Maintain at least a 2.25 CGPA as an undergraduate student. Maintain at least a 3.0 CPGA as a graduate student.</li> <li>• If the student loses their grant tuition savings due to their GPA, they will be notified that they will no longer be eligible for the grant tuition savings for subsequent sessions. The student will receive the prevailing tuition rate for their program (currently \$514*** for undergraduate programs and \$776 for graduate programs), be responsible for fees, and must work with Student Central to determine eligibility for other DeVry special pricing programs.</li> </ul>

\*Readmit student is defined as a student who has previously attended DeVry University but has not been enrolled in courses during the past 12 months or longer.

\*\*\*Non-TechPath students who enrolled prior to May 2020 follow the tuition rate of their Scholarship terms and conditions form. TechPath students will remain at the current prevailing rate.

<sup>+</sup>Bookstore fees are the responsibility of the student even during first session of enrollment.
